- 3. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-III or Class-III.
- 4. Bids shall be received only "on line" on or before 5.00 P.M of 06.03.2024.
- 5 Bids received on line shall be opened at 11.00 A.M. on 07.03.2024 in the office of the Executive Officer, Talcher Municipality, Talcher in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

(a) The Engineer contractor willing to avail the Exemption of E.M.D will submit the scan copy affidavit to avail the exemption along with bid document and the original affidavit, original registration certificate shall be submitted in the office of the undersigned on or before date & time of opening of bid above during office hour on working days for recording necessary entry for exemption of EMD in the sealed cover failing which the bid shall be rejected.
- (b) ST/SC contractors desirous of availing exemption of EMD should submit an attested copy caste certificate duly issued by the competent authority.
- 7. The received tender shall remain valid for a period of 90 days from the date of opening of the bid.
- 8. They should submit the affidavit regarding Correctness and no relationship with the tenderer.
- 9. Other details can be seen in the bidding documents.
- 10. The authority reserves the right to cancel any or all bids without assigning any reason.
