Quotation/Tender Call Notice

Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour operators/Private Indivisulas for providing One no. of AC petrol/diesel driven vehicles like TUV-300 or BOLERO-ZLX or equivalent model having seating capacity not more than ten including driver which shall confirm the terms and conditions(Annexure-A) for official use in Angul Municipality Office,Angul on monthly rent basis.

1. The service provider shall have a valid OGST registration to participate in the tendering.
2. The service provider, participating in the bidding process under the jurisdiction of Municipal Corporations, shall be registered on GeM platform.
3. The vehicle must be in road worthy condition, shall be not more than 3 years old from the date of initial registration and must have a valid registration certificate, Insurance certificate, Fitness Certificate, Pollution Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc. mandatory for plying of vehicle.
4. The driver of the vehicle must have a valid Driving License for driving transport passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
5. The driver should be well behaved, gentle and obedient in nature.
6. A sum of Rs.5,000/- (Rupees Five thousand) only shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Executive Officer, Angul Municipality and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
7. The monthly rate of hire charges be quoted separately in general bid information (excluding fuel & lubricants)
8. The vehicle must achieve a fuel efficiency of 10 KM per litre.
9. The details of make and manufacturer of vehicle, registration no./mileage(kms covered per litre) and name of the Driver, Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender(Annexure-B)
10. The Quotation completed in all respect should reach the undersigned on or before 07 March 2024 by 01.00 P.M, and shall be opened on the same day at 03.30 P.M. in presence of the bidders or their respective authorized representatives.
11. The application form of quotation/tender containing General Bid information & terms and conditions for hiring of vehicle etc. will be available in the office of Angul Municipality, Angul from 11.00 A.M. to 03.00 P.M. on every working day from dt.28.02,2024 to 07.03.2024 (up to 12.00 Noon) on payment of Rs,1000/-
